**IF you can answer YES to any of the following questions involving an \*item listed below that you are about to deposit or cash, please notify one of our 4 branch managers immediately because these are features of known and active scams.**

- Have you been informed you were a winner in a lottery or sweepstakes?
- Have you been informed that you have been a winner in a lottery or sweepstakes you did not enter?
- Have you been told to keep information regarding this \*check confidential?
- Is this \*check related to a job you have found on the Internet or newspaper, where you are being asked to wire or send funds to another individual or business?
- Have you been asked to assist in any distribution of money (for example, as heir to an estate) from someone you do not know?
- Is the \*check drawn on a business or individual different from the person or business you are communicating with?
- Is the \*check from an individual you have communicated with via email?
- Have you been instructed to send funds to another party as soon as possible?
- Is the \*check proceeds for an item you sold on the Internet such as a car, boat, horse, jewelry, etc?
- Is the \*check drawn on a business or individual different from the person buying your item or product?
- Is the amount of the \*check more than the selling price of the item?
- Have you been informed that you can make money as a mystery shopper for a fee?
