

# THE FARMERS BANK SCHOLARSHIP Information & Instructions

In 2020 Farmers Bank is awarding eight \$2,500 scholarships to graduating high school seniors that reside in Isle of Wight County, Southampton County, the City of Franklin, the City of Suffolk, the City of Chesapeake, the City of Portsmouth, the City of Norfolk, the City of Virginia Beach and home school students in those school districts.

Graduating seniors who wish to compete for the scholarship must complete a "Farmers Bank Scholarship" application form.

The scholarship will be awarded by a committee of five individuals, independent from Farmers Bank and the eight best applicants will be awarded.

#### **CRITERIA**

- 1. COLLEGE ACCEPTANCE The applicants must be seniors who have accepted an admission as a <u>full</u> <u>time student</u> from an accredited two or four-year college or university.
- 2. FINANCIAL NEED The financial circumstances of the applicants will be a factor in the awarding of the scholarship. Demonstrated need will be given careful consideration.
- 3. SCHOLASTIC AND ACADEMIC ACHIEVEMENT The applicants must possess an "Above Average" academic record.
- 4. PERSONAL TRAITS The recipients of the Farmers Bank Scholarship must be strong in those traits that exemplify high moral character. All participants should possess an extremely high degree of honesty, self-respect, reliability, self-control, personality, service, patriotism and responsibility. Applicants should also possess leadership ability and be actively involved in school and community activities.

#### PAYMENT OF SCHOLARSHIP BENEFITS

The Farmers Bank Scholarship will be made payable to the college and student upon receipt of verification of enrollment with the student's Identification Number. Payment will be issued by August of the year in which the scholarships are awarded. Farmers Bank does not provide special instructions with the scholarship payment, it is up to the student to coordinate with their school's Finance Office as to how the scholarship payment is applied to the student's account.

- All completed applications must be postmarked by MARCH <sup>6th</sup>, 2020 to: Farmers Bank Attn: Marketing Dept, P. O. Box 285, Windsor, VA 23487 or submitted to a Farmers Bank Branch or to school guidance director by MARCH <sup>6th</sup> 2020. No additional applications will be accepted after this date.
- 2. A transcript of high school grades must be included with each application.
- 3. Please provide only the information requested on the application, no more, no less.
- 4. APPLICATIONS THAT DO NOT FOLLOW THIS FORMAT WILL NOT BE CONSIDERED.
